EXTRACTS FROM THE VERMONT STATUTES

Restrictions as to minors et al. A clerk shall not issue a marriage license when either party to the intended marriage is:

1. A male under the age of twenty-one years or a female under the age of eighteen years without the consent in writing of one of the parents or the guardian of such minor, if there is one competent to act.

A person shall not solemnize the marriage until five days after the certificate required by this section has been issued, excluding the date of its issue. Except as modified by Section 3158, Vermont Statutes, Rev. of 1947.

Sections 238 and 241 of No. 170 of the Acts of 1951, require that a blood test be made on each applicant not more than thirty days prior to the date of application and that the certificate of marriage shall be delivered within sixty days from the date of issue to a person authorized to solemnize marriage.

The person solemnizing a marriage shall receive the certificate from the parties, fill any blanks remaining therein, add the date of marriage and his official signature, and return the certificate to the clerk's office from which it was issued within ten days from the date of the marriage. If he fails so to do he shall be fined not less than ten dollars. A person who solemnizes a marriage, without first obtaining of the parties the certificate required by law, shall be fined not less than ten dollars.
